## **Lesson Four Vocabulary Words**

**Government:** the office, authority, or functioning organization that makes laws and controls a political unit such as a city, state, or country. (Recommended Vocabulary K-9, Qatar English Standards, Grade 7)

**Guilty:** responsible for having committed a crime. (Recommended Vocabulary K-9, Qatar English Standards, Grade 9)

**Executive Authority:** the power to enforce laws. In Qatar, executive authority is held by the H.H. the Emir and the Council of Ministers.

**Innocent:** not responsible for having committed a crime. (Recommended Vocabulary K-9, Qatar English Standards, Grade 9)

**Judicial Authority:** the power to interpret the meanings of laws as applied to specific cases, as in judges in the courts of law.

**Legislative Authority:** the power to make laws. In Qatar legislative authority is held by the Advisory Council, in consultation with H.H. the Emir and his ministers.

**Traffic:** the vehicles and pedestrians moving along a route. (Recommended Vocabulary K-9, Qatar English Standards, Grade 6)

**Vehicle:** a device with wheels used to transport people or objects. (Recommended Vocabulary K-9, Qatar English Standards, Grade 7)


